At the United Nations (UN) General Assembly High-Level Meeting, world leaders have approved a new Political Declaration on “*Universal Health Coverage (UHC): expanding our ambition for health and well-being in a post-COVID world*”.

The declaration is hailed as a vital catalyst for the international community to take big and bold actions and mobilize the necessary political commitments and financial investments to attain the UHC target of the Sustainable Development Goals (SDGs) by 2030.

25% of children at risk of poverty or social exclusion in 2022

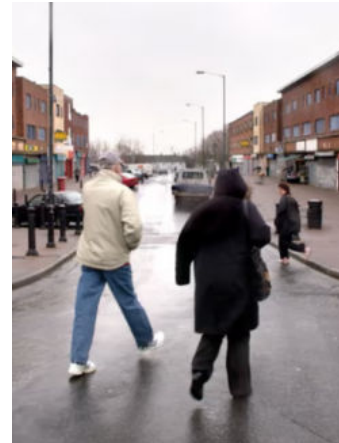
Policy must tackle root causes of England's record mental ill-health, says report
