[WHO releases guidance on gender inequalities and antimicrobial resistance](#)

One of the largest challenges in public health is Antimicrobial Resistance (AMR). AMR, like any other topic related to public health, has a significant equity dimension along different kinds of determinants. Women and girls face barriers in healthcare access which is reflected in diagnosis and treatment, while men may be more exposed to antibiotics through work in agriculture, animal husbandry or slaughterhouses.

Eurostat's has released a large report on equality and non-discrimination. It highlights key disparities across various social groups within the EU, covering areas like health, education, the labour market, and income. The results once more underscore persistent challenges faced by individuals based on sex, age, disability, and ethnicity, while also emphasising gender-based violence and discrimination. The report provides valuable data for policymakers and NGOs to address these inequities and ensure more inclusive policies across Europe .

LGBTI individuals in Europe face specific barriers when accessing healthcare. A new Council of Europe reports shows that many face discrimination and poor mental health due to lack of inclusive care. The report urges governments to act by improving training, updating laws, and collecting better data to address these disparities. In addition, transgender and older LGBTI people are highlighted as groups needing urgent attention. The report offers a clear path for creating fairer, more inclusive healthcare systems across Europe.

The Czech Ministry of Health has been responsible for ensuring access to healthcare to Ukrainian refugees. A large part of the refugees were women and children, and services had to be adapted to meet their specific needs. Together with UNICEF, steps were also taken to train Ukrainian healthcare workers to work in the Czech system, while Roma health mediators were also put in place.

A wide range of structural determinants, including criminalisation, stigma and inequitable gender norms, have an impact on the inequities in the burden of HIV. To understand these determinants, this research conducted a scoping review of 17 HIV modelling studies, revealing causal pathways which could be useful to predict impacts and adapt interventions accordingly.

It is difficult to get a grasp on the degree to which people have unmet healthcare needs. Even more difficult is to get a grasp of what the gender differences are within this context. New research from Türkiye analysed health survey data shows that not only 15,4% of individuals cannot access healthcare due to financial constraints, there is also a large gender disparity.
